## **Terms and Conditions**

- 2. Only residents of Australia aged 18 years of age or older (Participant) are eligible to redeem the gift with purchase OR if accompanied by a guardian. The Promotion commences and free gifts are available between core centre trading hours on Monday 13 January 2025 until Sunday 26 January 2025 or the time that a total of 250 free gifts have been claimed.
