

ERINA FAIR / ECOYA CANDLE GIFT WITH PURCHASE

Terms and Conditions

1. Information on how to participate in the 'Ecoya Candle Gift with Purchase' promotion form part of these Terms and Conditions. Participation in the Ecoya Candle Gift with Purchase ("Promotion") is deemed acceptance of these Terms and Conditions.
2. This Promotion is open to persons aged 18 years or older.
3. The promotion commences at 9:00am AEST on Tuesday 01 September 2026 and ends at AEST 5:00pm Wednesday 30 September 2026 OR WHILE STOCKS LAST, whichever comes first.
4. The promotion consists of five hundred (500) separate Ecoya 'Madison Collection' 400gm Candles with a RRP value of \$49.95AUD each that are redeemable with any \$175 spend at participating Fashion, Beauty and Homewares retailers as per the redemption process below, over the promotional period outlined above.
5. Entries are deemed to be received at the time of receipt by the Promoter and not at the time of transmission or deposit by the entrant. Records of the Promoter and its agencies are final and conclusive as to the time of receipt.

PRIZE CONDITIONS

20. Once the allocation of 500 Ecoya Madison Candles has been exhausted (redeemed) the promotion will be deemed complete and finished.
21. There is a total of 500 gift with purchase prizes to be redeemed, valued at \$49.95 RRP per prize. Total prize value over the thirty-day promotional period is \$24,975 (500 units x \$49.95 RRP).
22. Gift with purchase, or any unused portion of a gift with purchase, are not transferable or exchangeable and cannot be taken as cash, unless otherwise specified.

GENREAL
